Mindspace REIT Achieves GRESB Sector Leader 2025 Status for Outstanding ESG Performance

Mindspace REIT achieves Green Star and 5-star GRESB rating for the Third Consecutive Year; Reaffirming its global ESG Leadership in Sustainable Real Estate

Mumbai, October 15, 2025 – Mindspace Business Parks REIT (BSE: 543217 | NSE: MINDSPACE) ('Mindspace REIT'), owner and developer of quality Grade A office portfolio, today announced that it has been named **Global and Regional Sector Leader** in the **Development and Standing Investment benchmarks**, respectively, and secured a **5-star GRESB rating for the third consecutive year**, along with a **Green Star** recognition. The GRESB Sector Leader Awards recognize real estate and infrastructure companies, funds and assets, that have demonstrated outstanding leadership within their peer groups.

The REIT achieved an overall Standing Investment score of **93 out of 100**, ranking 2nd among 20 peer entities in the Office/Asia/Listed segment. This strong performance earned Mindspace REIT the Regional Sector Leader in Standing Investment – Listed Asia Office recognition. In Development Benchmark, Mindspace REIT scored a perfect **100 out of 100**, while securing the **1st position in Development Score** across Office/Asia, Office/Listed, and Asia/Listed categories.
